Prayer or Relief Sought

Prayers:

- 1) that the Honourable First Appellate Authority (FAA) be pleased to admit this appeal and inquire into the ma ers raised herein.
- 2) that the Honourable FAA be please direct the disclosure of all informaon sought in the instant RTI applicaon free of charge as is the right of this Appellant under Secon 7(6) of the R TI Act.

Grounds:

This Appellant is aggrieved by the decision of the CPIO for the reasons stated below:

- a) The CPIO has contended that all the informaon sought in the instant RTI applicaon is exempt from disclosure under Secon 8(1)(j) of the RTI Act as it is third party informaon and relates to the privacy of an individual. This Appellant believes that both contenons are without due applicaon of mind on the part of the said CPIO.
- b) First, Secon 8(1)(j) of the RTI Act exempts only such personal informaon which has no relaonship to any public acvity or public interest or where disclosure may cause unwarranted invasion of the privacy of an individual. The Embassy of India in Kuwait discloses most of the informaon sought in the instant RTI applicaon proacvely on its website (see pages 3-6 in the alachment for a copy of the webpages containing similar informaon downloaded from its website). Clearly such a step would not have been taken if there were no public interest in such disclosure. The very acts of

collecon and display of such informaon by the Embassy of Kuwait are indicave of the very public nature of such acvies. So the CPIO of this Embassy has erred in his interpretaon of Secon 8(1)(j) of the RTI Act.

c) Second, for the purpose of invoking the protecon of Secon 8(1)(j) of the RTI Act, the ground that the requested informaon relates to the privacy of an individual is not adequate. The test in Secon 8(1)(j) is much stricter. Disclosure is not permissible only when it will cause unwarranted invasion of the privacy of the individual. Nothing in the decision of the CPIO indicates as to how this effect, namely, unwarranted invasion of the privacy of the deceased Indian Workers would be caused by disclosing the informaon requested in the instant RTI applicaon.


d) Third, Secon 8(1)(j) of the RTI Act gives effect to the fundamental right to privacy of an individual. This has been recognised by a 9-Judge Constuon Bench of the Supreme Court of India in August 2017. Fundamental rights by their very nature are available to individuals who are alive. This Appellant has sought informaon about Indian Workers who unfortunately died in the UAE. The CPIO cannot claim the applicaon of the right to privacy for a deceased person. Therefore there is no valid basis to invoke any exempon under the RTI Act to reject the informaon that this Appellant has sought in the instant RTI applicaon.
