### Information sought:

The Complainant sought copy of following documents:

- Joint Doctrine for Perception Management and Psychological Operations;
- Joint Doctrine for Air and Land Operations; and
- Reforming the National Security System.

## **Grounds for the Complaint:**

The CPIO has not provided the desired information.

## **Relevant Facts emerging during Hearing:**

The following were present:-

**Complainant:** Present in person.

**Respondent:** Col. Abhinandan Singh, Col (Doctrine) & Rep. of CPIO, HQ Integrated Defence Staff, Kashmir House, New Delhi present in person.

Complainant stated that the denial of information under Section 8(1)(a) of the RTI Act on paras 1 & 2 is unsubstantiated to begin with, further that he has had access to similar published doctrines in the past. He furthermore brought the attention of the bench to the issue of external links not functioning properly on the HQ IDS website and in this context referred to the guidelines of GOI stipulating web maintenance by public authrities. Complainant prayed that directions be ordered to provide the Manual of Departmental Security Instructions, 1966 as both CPIO & FAA have reasoned that disclosure of the Joint Doctrines is exempted as they contain materials that are essentially meant for official use only and which should not be communicated to anyone except for official purposes. He urged that the security classification accorded to both documents render it as "Restricted" and for him to contest the same he needs access to the aforesaid Manual to have knowledge about the qualifying criteria laid down therein for classifying such documents. Complainant also stated that he is not pressing for information on para 3 of the RTI Application upon Commission's observation regarding the lack of knowledge of the Respondent to identify the probable holder of information for the said para.

Commission summarily rejected the prayer of the Complainant seeking the Manual as it amounts to seeking additional information which was not part of the original RTI Application.

CPIO presented the Joint Doctrines for Commission's perusal to weigh in the exemption of Section 8(1)(a) of RTI Act while submitting that the primary reason for denying the same was that it pertains to specific Land & Air operations.

#### **Decision**

Based on the nature of relief sought in the Complaint, the instant case is treated as Second Appeal.

Commission observes from the perusal of relevant record presented by the CPIO that denial of information under Section 8(1)(a) of RTI Act is completely

unwarranted. The rationale of the CPIO to invoke Section 8(1)(a) of RTI Act is far from convincing and rather appears labored.

Commission directs the CPIO to provide copy of Joint Doctrine for Perception Management and Psychological Operations as well as Joint Doctrine for Air and Land Operations as sought in para 1 & 2 of the RTI Application to the Appellant free of cost within 15 days from the date of receipt of this order. A compliance report to this effect shall be duly sent to the Commission by the CPIO.

## The complaint is disposed of accordingly.
