6) Brief facts leading to the appeal :

6.1) On 07/07/2017, this Appellant despatched by Speed Post, a request for information to the CPIO mentioned at para #2 above, along with the prescribed application fee, stating as follows (**Annexe 1**):

"Apropos of paras #164-165 of the Budget-related speech of the Hon'ble Finance Minister delivered in the Lok Sabha on 01 February, 2017 relating to the issuance of Electoral Bonds, I would like to obtain the following information from your public authority:

- 1) The total number of representations or petitions or communications, by whatever name called, received by the Government of India, till date, from donors regarding the need for maintaining confidentiality of their identity while making donations to political parties;
- 2) A clear photocopy of all representations or petitions or communication by whatever name called, described at para #1 above;
- 3) A clear photocopy of the Draft Electoral Bond Scheme prepared by your Department for consultation with the Reserve Bank of India and the Election Commission of India.

I am a citizen of India. I have enclosed an IPO (bearing #38F 191011) for Rs. 10/- towards payment of the prescribed application fee. I would like to receive the information specified above, at my postal address mentioned above. Kindly inform me of the additional fee payable for obtaining the said information.

As the list of CPIOs and FAAs displayed on your official website at the URL: <http://dea.gov.in/cpio-appellate-authority>, does not clearly indicate the name and contact details of the CPIO responsible for the subject matter of 'Electoral Bonds', I am constrained to send this RTI application to your RTI Cell. Kindly forward this RTI application to the appropriate CPIO for disposal as per the provisions of the RTI Act."

6.2) Subsequently, the instant RTI application was delivered to this Public Authority on 10/07/2017 (**Annexe 2**).

6.3) This Appellant has not received any reply from the CPIO of this Public Authority till date.

7) Prayers or relief sought :

This Appellant prays that this First Appellate Authority be pleased to:

- 1) **admit this appeal and inquire into the matters raised herein; and**
- 2) **direct the concerned CPIO to disclose all information specified in the instant RTI application free of charge as is this Appellant's right under Section 7(6) of the RTI Act.**

8) Grounds for the prayer or relief :

8.1) According to Section 19(1) of the RTI Act an RTI applicant, who is aggrieved by the fact that no decision has been received in relation to his or her RTI application, may prefer an appeal to the officer senior in rank to the CPIO within 30 days of the date on which such decision ought to have been made. The instant RTI application was despatched to the Respondent Public Authority on 07/07/2017 (**Annexe 1**). As per the Speed Post consignment tracking report published by the Department of Posts on its website, the said RTI application was delivered to this Public Authority in 10/07/2017 (**Annexe 2**). More than 30 days have lapsed since the delivery of the instant RTI application to this Public Authority. No response has been forthcoming from any CPIO of this Public Authority. Therefore under the terms of Section 19(1) of the RTI Act, this is a fit case for submitting an appeal to this Public Authority. **Hence the submission of this appeal to this Hon'ble Appellate Authority.**

8.2) According to Section 7(1) of the RTI Act, upon receiving an RTI application and finding that one's Public Authority holds the information sought, in material form, a CPIO has only two courses of action open to him or her. Such CPIO is required to either furnish the requested information on payment of the additional fee at the rates prescribed in the RTI Rules, 2012 or reject the request for any of the reasons specified in Sections 8 or 9 of the RTI Act. The CPIO of this Public Authority has chosen neither course of action till date. It is not open for the CPIO to sit endlessly on an RTI application without sending even an acknowledgement of receipt of the instant RTI application. This Appellant is aggrieved by the inaction of the CPIO of this Public Authority. **Hence the submission of this first appeal to this Hon'ble Appellate Authority.**

8.3) Further, according to Section 7(2) of the RTI Act, where a CPIO fails to give a decision on the information request within the period of 30 days specified in Section 7(1) of the RTI Act, it shall be deemed that the request for information has been rejected. As more than 30 days have lapsed since the receipt of the instant RTI application by this Public Authority, it is to be deemed that the instant RTI application has been rejected. As Section 19(1) of the RTI Act also permits a citizen aggrieved by a decision of the CPIO (deemed to be rejected in the instant case) to prefer an appeal against such decision, to an officer senior in rank to such CPIO, this ground is also satisfied in the instant case. **Hence the submission of this first appeal to this Hon'ble Appellate Authority.**

8.4) Further, according to Section 7(6) of the RTI Act, where a CPIO fails to supply the information sought within the period of 30 days stipulated in Section 7(1) of the RTI Act, the applicant has a right to obtain the information free of charge. It has already been shown conclusively above, that the CPIO of this Public Authority has not bothered to send any reply to the instant RTI application despite the lapse of the statutory deadline of 30 days. This Appellant, therefore has a right to receive all the information specified in the instant RTI application free of charge, under Section 7(6) of the RTI Act. **Hence the submission of this first appeal to this Hon'ble Appellate Authority.**

8..5) Further, as this Appellant has not received any reply from the CPIO of this Public Authority, he has no knowledge of the name or the contact details of the First Appellate Authority designated by the Section/Division for responding to RTI applications on the subject matter of "Electoral Bonds". Therefore this Appellant is exercising his right of appeal under Section 19(1) of the RTI Act by submitting this appeal to the First Appellate Authority linked to the CPIO mentioned at para #2 above as per details provided on the official website of this Public Authority at the URL: <http://dea.gov.in/cpio-appellate-authority>. **Hence the submission of this first appeal through the RTI Cell of this Public Authority.**

9) I hereby verify that the aforementioned facts are true to the best of my knowledge. I also declare that I have authenticated the Annexes to this appeal.

ORDER

2. The applicant in his appeal dated 17.08.2017, sought the following information:


