Sub: Submission of request for information under *The Right to Information Act, 2005*

I would like to obtain the following information from your public authority under the RTI Act about vigilance related and whistleblower complaints received against officers and employees of the Delhi Jal Board (DJB), during the period 01 April, 2013 to 28 February 2017:

- 1) The year-wise total number of vigilance related and whistleblower complaints received against officers and employees of DJB;
- 2) The year-wise total number of vigilance related and whistleblower complaints against officers and employees of DJB inquired into by your own staff;
- 3) The year-wise total number of vigilance related and whistleblower complaints resulting in the launch of prosecution against the accused officers and employees of DJB under the *Prevention of Corruption Act, 1988* (PC Act) and Sections 169 and 409 of the *Indian Penal Code, 1860* along with the total number of persons accused in each case;
- 4) The year-wise total number of vigilance related and whistleblower complaints resulting in the conviction of the accused officers and employees of DJB under the penal laws specified at para #3 above;
- 5) The year-wise total number of vigilance related and whistleblower complaints resulting in the initiation of disciplinary action against the accused along with the total number of officers and employees of DJB proceeded against in each case;
- 6) The year-wise total number of vigilance related and whistleblower complaints resulting in major penalty being imposed along with the total number of officers and employees of DJB penalised in each case. Please provide a clear description of the penalty imposed in each case;
- 7) The year-wise total number of vigilance related and whistleblower complaints resulting in minor penalty being imposed along with the total number of officers and employees

of DJB penalised in each case. Please provide a clear description of the penalty imposed in each case;

- 8) The total number of vigilance related and whistleblower complaints against officers and employees of DJB pending disposal as on date of this RTI application along with the current status of action taken in each case.
