2) According to Section 7(1) of the RTI Act, upon receiving a request for information that is held by his public authority a CPIO has only two courses of action open to him. He is required to either furnish the requested information on payment of the additional fee as per the rates prescribed in the RTI Rules, 2012 notified by the Government of India or reject the request for any of the reasons specified in Sections 8 or 9 of the Act. The CPIO cannot sit endlessly on an RTI application without sending any response to the RTI applicant for 30 days. The CPIO of this Public Authority has not sent any response within the said time limit,

3) According to Section 7(2) of the RTI Act where a CPIO fails to send a response to an RTI application within the time limit specified in Section 7(1) of the Act, it shall be deemed that the information sought has been refused. According to Section 19(1) of the RTI Act, a citizen may submit a first appeal to the Public Authority even where a CPIO fails to give any decision on his RTI application.
