Sub : Regarding implementation of "Pre e-Form 4 Result Review software" application for reviewing results of applicants already included in Part Draft and carrying out Quality Checks.

Sir/Madam,

With reference to the subject cited above, as you are aware that the undersigned requested the Hon'ble Supreme Court in the last hearing held on 2nd July 2018 to exclude from the Complete Draft names of some persons whose names have appeared already in Part Draft but who are found to be ineligible through Family Tree Investigation or Special Verification or in CRCR Quality Checks. The Hon'ble Court has approved the aforesaid proposal of the undersigned. The order of the Hon'ble Court dated 2nd July 2018 is enclosed as **Annexure A**. In order to execute this order of the Hon'ble Court a software application is developed which will be rolled out from today (4th July 2018) at all NSK laptops. The LRCRs will be required to review results of applicants already informed in Part Draft for any discrepancies and if the result is to be reviewed the same to be recorded through this software application named "**Pre e-Form 4 Result Review software application**".

With approval of the Hon'ble Court, eligibility of those who are FTRRS and SVRRS Reject but included in Part Draft needs to be freshly examined. Also those verified during Phase 2 OVR. In addition, if any change is required to be done for any person whose results recorded in Post Part Draft but Pre e-Form 4 stage. Hence e-Form 4 Results Review Module will allow data entry for the following:

1. **FTRRS Reject** - List of members included in Part Draft but result of family tree verification has found to be rejected subsequently. These will be displayed as "**FTRRS (Pending)**" in this Module.
2. **SVRRS Reject** - List of members included in Part Draft but result of special verification for applicants submitting GP/CO/LM Certificates has found to be rejected subsequently. These will be displayed as "**SVRRS (Pending)**" in this Module.
3. List of members included in Part Draft but their results of family tree and special verification both have found to be rejected subsequently. These will be displayed as "**FTRRS_SVRRS (Pending)**" in this Module.
4. "**Pending**" - List of members included in Part Draft but their results are recorded as "Pending" in the result recording excel uploaded by LRCRs. The LRCRs will now be required to select this dropdown and record the eligibility of the applicant as Yes/No/Hold/e-Form 4 3(3), as applicable.

5. **New (Pending):** In addition, some ARNs whose data were not shared earlier but appearing in the Baselines Certificate provided by the DRCRs. These data have been newly digitized and will require fresh recording of their decision. CVRs for these will be provided by 6th July, 2018 and their disposal completed through DMIT and their results recorded in CVR 9th July, 2018. It may be noted that the CVR may not contain information about details of documents which need to be filled up by hand.

Data entries for the above 5 cases are mandatory.

6. **Results Review of any members for whom LRCR decision already recorded during the period after Part Draft but before e-Form 4.** These will be DIO listed as "Yes" and "No" in the software module - There will also be option to review result of any ARN not falling under any of the categories mentioned above. Under the "Yes" and "No" dropdowns, the LRCR can search for any ARN member(s) of which has been marked as "Yes" or "No" in 'post part draft pre e-Form 4' phase, if any need of review arises. All data under these dropdowns won't be displayed but will be shown only for the particular ARN searched. Data entries for the above 5 cases are not mandatory.

Further you are requested to ensure implementation of the following additional instructions given below:

1. All FTRRS results have been shared through FTRRS cumulative Report sent on 6th June 2018. Thereafter the delta report was sent on 25 June 2018. If result is not received for any member, then DMIT to be done and results recorded.
2. Cumulative SVRRS results were shared on 6th June 2018. Another set of results of hearings conducted later was shared on 3th July 2018. The last set of SVRRS Delta Results will be shared on 8th July 2018.
3. If results of any member (whether SV or Family Tree or any other reason) are left, disposal to be completed by DMIT and results recorded.
4. You are requested to inform the LRCRs on this matter through conduct of a meeting and ensure implementation at the earliest. The user manual for "Pre e-Form 4 Results Review software application" is enclosed as **Annexure B**.
5. **The last date of completion of data entry in e-Form 4 and Pre e-Form 4 Result Review software application is 9th July, 2018.**
6. In addition, QCs need to be carried out by CRCRs or by LRCRs themselves. These QCs need to be performed with the aim of ensuring that only those eligible are found entry in Complete Draft and ineligible are scrupulously kept out. Similarly, those deserve to be included should not be left out. The DRCRs need to identify areas - Circles or NSKs or Villages/ wards which need to be covered for QCs. The following types of cases will require results entry:
 - a. Change in final eligibility for QC cases (if not pushed through CRCR QC & Review XIDDHANTA),

- b. Change in final eligibility for children etc. of cases pushed through CRCR QC & Review XIDDHANTA,
- c. Any other changes required in e-Form 4 results already entered and synced.

For all the above-mentioned types, changes will be allowed to be made through a Central Correction Portal which will be operationalised from 10th July, 2018. In order to ensure organised record keeping, data for such cases will have to be maintained in the Excel format enclosed as **Annexure C**.

7. Further, all DRCRs need to be cautious about freshly marked e-Form 4 3(3) cases. All cases to be scrupulously checked and it should be ensured that CRCR and DRCR orders are recorded and kept in ARN folders.
8. For cases pushed through XIDDHANTA for CRCR QC & Review, it should be ensured that hard copies of CRCR Orders are available in the ARN Folders.
