The pointwise information is as under:

- The latest version of the rules framed under the J & K Public Safety Act, does not pertain tous. It can be had from concerned government department or agency.
- 2. The law in this regard is clear that subjective satisfaction of the District Magistrate is required on the dossier provided to him for making detention. The mention of SOP made by you in point No: 02 is factually, as well as, legally misconceived.
- 3. The information would impede the process of investigation as is covered under exemption clause 8(g) of J & K RTI-2009.
- 4. It is obvious that age of a person can be ascertained either by D.O.B Certificate or by Medical certificate.
- 5. Same can be had from the office District Magistrate, because the PSA detension orders are issued by District Magistrate.

If you are not satisfied with the information, you have right to appeal before FAA, i. e. Additional Sueprintendent of Police, District Budgam.
