### Re: Presidential Assent to Nigeria's Freedom of Information Bill 2004

I write as director of the Commonwealth Human Rights Initiative (CHRI), to bring your urgent attention the status of Nigeria's Freedom of Information Bill 2004 and to urge you to ask President Olusegun Obasanjo to give his assent to the law at the very earliest.

The present Bill is a product of long efforts by civil society and a process of consultation with government. The World Bank has been encouraging of a Freedom of Information law and has been known to make such a law a conditionality of further aid disbursements. Nigeria committed to enacted the Freedom of Information Bill in its poverty reduction strategic paper where it stated that the Right to Information Act will foster openness and feedback by streamlining and rationalizing the system for information collection, collation, storage and dissemincation on a timely basis.' However CHRI is concerned that Presidential assent is yet to be given. Elections are looming and there is a very real threat that the Bill will not become law in time and the process of passing the law will need to start all again with a new Government.

I am therefore writing to urge your organisation to once again press President Olusegun Obasanjo to give his assent to the Bill which has already been through all the necessary legislative processes. CHRI has also written to the President as have many other concerned national and international organisations.

I hope you will add your voice and efforts to this. I look forward to a word in response.
