The Commonwealth Human Rights Initiative (CHRI) is an independent, non-partisan, international non-governmental organisation, mandated to ensure the *practical* realisation of human rights in the countries of the Commonwealth. In 1987, several Commonwealth professional associations founded CHRI. They believed that while the Commonwealth provided member countries a shared set of values and legal principles from which to work and provided a forum within which to promote human rights, there was little focus on the issues of human rights within the Commonwealth.

The objectives of CHRI are to promote awareness of and adherence to the Commonwealth Harare Principles, the Universal Declaration of Human Rights and other internationally recognised human rights instruments, as well as domestic instruments supporting human rights in Commonwealth member states.

Through its reports and periodic investigations, CHRI continually draws attention to progress and setbacks to human rights in Commonwealth countries. In advocating for approaches and measures to prevent human rights abuses, CHRI addresses the Commonwealth Secretariat, member governments and civil society associations. Through its public education programmes, policy dialogues, comparative research, advocacy and networking, CHRI's approach throughout is to act as a catalyst around its priority issues.

The nature of CHRI's sponsoring organisations allows for a national presence and an international network. These professionals can also steer public policy by incorporating human rights norms into their own work and act as a conduit to disseminate human rights information, standards and practices. These groups also bring local knowledge, can access policy makers, highlight issues, and act in concert to promote human rights.

PROGRAMME HIGHLIGHTS 2010-11

STRATEGIC INITIATIVES (formerly Human Rights Advocacy)

Objectives of the Programme

Commonwealth - To advocate around police reforms and for a Commonwealth Expert group on Policing, human rights defenders with Commonwealth agencies, highlight human rights situations and provide a platform for human rights in the Commonwealth during the CHOGM 2011, assist Commonwealth Secretariat in its efforts to implement the Commonwealth Model National Plan of Action for Human Rights, undertake human rights centred fact-finding missions to Commonwealth countries, where necessary

UNHRC –Promoting accountability and cooperation of Commonwealth members of the UNHRC, sustain cross regional civil society networks to strengthen and influence the UNHRC, train and capacity build CSOs from the Commonwealth on the UNHRC and the UPR.

Activities

- CHRI made submissions to the Commonwealth Eminent Persons Group created by CHOGM 2009 to make recommendations on reforms of the Commonwealth
- CHRI with our partners requested the President of the UN Human Rights Council to allow NGO
 participation at the Retreat of the 'Working Group on the Council Review'. Eventually, CHRI
 also participated in the Retreat and presented before government delegations on the UPR.
 CHRI made presentations alongside partners at the retreat on sensitive issues including
 country specific scrutiny on human rights.
- In January 2011, CHRI issued a statement condemning the killing of David Kato, a leading Ugandan Gay activist.
- January-March, CHRI supported several campaigns around the revolutions in the Middle East, especially in Tunisia and Egypt, and participated in a successful campaign on the suspension of Libya from the UN Human Rights Council.
- March, made a submission to the Commonwealth Eminent Persons Group on the need for a Commonwealth Expert Group on Policing.
- March, launched Easier Said Than Done a report on the commitments and performances of Commonwealth countries at the United Nations Human Rights Council (2010), the third in the series. The media release of the report was timed with the Commonwealth Day 2011. The report was highlighted in the media in a number of countries including: India, Malaysia, Maldives, Rwanda and Ghana. The report was also widely disseminated and discussed at various fora in which CHRI participated.
- March, participated in a Regional Consultation organised by Solidarity for Asian Peoples Advocacy Working Group on UN Human Rights mechanisms from 30-31 March 2011 in Bangkok, and worked towards the identification of joint initiatives for 2011-2012 along with other participants.
- From September 2010 to January 2011, CHRI conducted about 75 long interviews to collect primary data from NHRIs and civil society organisations from all over the Commonwealth. The data will be used in CHRI's report to CHOGM 2011, that will examine NHRIs in the Commonwealth and the extent to which they protect civil society space and human rights defenders. From January to March 2011, CHRI has been tabulating the collected data and supplementing it with secondary research. The report is expected to be launched in May/June

2011.

- Commonwealth Human Rights Initiative released Easier Said Than Done a report on the
 commitments and performances of Commonwealth countries at the United Nations Human
 Rights Council (2010). The report compares pre-election pledges made by 12 Commonwealth
 countries to the United Nations Human Rights Council, with each country's performance at the
 domestic and UN levels. This is the third report in its Easier Said Than Done series.
- CHRI is currently concerned with critiquing laws and attitudes within the Commonwealth regarding LGBTI advocates and supporting their fight against discrimination. This has led to first time discussion on this subject later at the recently held Law Minister's meeting.

ACCESS TO JUSTICE: POLICE REFORMS

Objectives of the Programme

To catalyse positive changes in policing across the Commonwealth, particularly in Ghana, East Africa, South Asia and India

Activities

India:

- CHRI continues to monitor independent oversight bodies' performance as well as liaise with them towards increasing efficiency and efficacy and brings out periodic reports. Besides the existing five functional Police Complaints Authorities (Kerala, Goa, Uttarakhand, Assam and Tripura) three new ones have been set up in Chandigarh, Haryana and Puducherry.
- Made a presentation in October before the Parliamentary Select Committee on the proposed Prevention of Torture Bill, 2010
- Met with the Home Secretary, Government of India, and the Joint Secretary (UT), Ministry of Home Affairs, Government of India, on the proposed amendments to Delhi Police (Amendment) Act, 2010
- Early this year the Kerala Police Act was passed in the Assembly. The Select Committee looking into the Bill took on board CHRI's suggestion and had held wide consultations in every district and as a result had proposed some 790 amendments to the original Bill. A long debate ensued in the House and 240 amendments were finally debated, discussed and passed. CHRI's seminal role in this process and our efforts duly acknowledged. Since then at CHRI's instance the J and K Chief Minister has agreed to a similar pre-legislative process.
- Recent policing publications in India range from (illustratively) policy briefs for government on designing oversight bodies, expert backgrounder for civil society activists, how to public primers on policing like "101 Things Things You Wanted To Know About Policing But Were Afraid To Ask", and a monthly broadsheet for constabulary called *Lok Police* that goes to police stations all across the Hindi belt.
- CHRI was invited to present at the International Police Executive Symposium Conference on Community Policing which was organised by the Kerala Police. CHRI was recognised at the conference by the Police Chief as the only organisation working in a sustained manner on systemic reforms of the police for over the last decade.
- Conducted monthly police trainings in Orissa, with Sub Inspector and Deputy Superintendent of Police level officers in accordance with an MOU with the Biju Patnaik State Police Academy (BPSPA) Orissa police for improved overall training of the police.
- CHRI challenged before the Kerala High Court a gruesome custodial death in the state which
 was marked with attempts by the police and government to cover up the issue and present
 barriers to an independent and impartial investigation. The High Court order transferring the
 investigation to the CBI was upheld by the Supreme Court on an appeal The Supreme Court

criticised heavily the role of the police as well as the government in trying to shield guilty officers and dismissed the appeal. This was a great victory for CHRI. It demonstrated that we could both engage with the police when possible, and confront them when required.

Have held seminars to get youth involved in the campaign for police reforms

South Asia:

- In 2010, the South Asia program was able to achieve considerable success in its objectives, the most important being that of raising demand for, and understanding of, police reform in the region. During the period under review, the program maintained close contact with all its regional partners, consolidated Network for Improved Policing in South Asia (NIPSA http://www.nipsa.in) as an important resource tool, and effectively implemented its commitments for the year 2010. This has given us the confidence to deepen our engagement on police reforms in the region in 2011.
- Published Feudal Forces: Reform Delayed 2010, Moving from Force to Service in South Asian Policing. The report is the third in the series that reviews political developments and their impact on police reforms in Commonwealth countries of South Asia. The reports have been very well received and will ground CHRI's future in-country advocacy for better policing.
- The second South Asia Visiting Programme was held in November 2010 in two Indian cities, New Delhi and Kochi. The idea of the Visiting Programme is to enable practitioners and civil society from the region to learn about police reform initiatives in India and draw lessons for their own work. The programme allowed the participants to deepen their knowledge on policing in the region. Following its success, it has been decided to repeat the programme again this year in October.
- In Bangladesh, following the training workshops organised last year on 'Role of Police in a Democratic Society and our Rights,' there was considerable interest in, and demands for repeating such efforts on a regular basis. One such training was held in April 2011.
- 2010 proved to be a good year for us in terms of our work in the Maldives; we were able to generate interest on the subject of police reforms, publish the 101 Questions in Dhivehi (July 2010), conduct a training workshop (July 2010), and review police reform efforts in the Maldives in Feudal Forces 2010. This work has given us good grounding and understanding of policing issues in the Maldives and helped us build sustainable partnership with the Maldivian Democracy Network (MDN) and the Human Rights Commission of the Maldives (HRCM). We have also established good contacts with the Maldives Police Service and the Police Integrity Commission. We are now looking to build on the momentum generated and expand our reach beyond the capital Male. In February, developed a 2-part survey for the police and for civil society, to assess the efficacy of the Maldives Police Strategic Plan 2007-2011, before the new plan of 2011-2015 comes into action. The survey is to be administered with the help of the Maldivian Democracy Network (MDN). The Maldives police have also extended their cooperation.

East Africa:

- Building on research and well received publications that highlighted little known police structures and weaknesses in accountability mechanisms in East Africa, CHRI in partnership with APCOF, has engaged in the last couple of years with stakeholders including the Eastern Africa Police Chiefs Cooperation Organisation (EAPCCO), the national police forces, government, national human rights institutions, media, academia, the donor community and civil society in Kenya, Tanzania, Uganda, Rwanda and Burundi toward articulating common standards for policing for these countries as they evolve into the East African Community.
- The Common Standards publication, an outcome of these efforts, is now being disseminated widely and is in the process of being integrated into the design of all policing projects in the region, both at the regional and national levels. Most recently CHRI and APCOF resourced a

Mombassa conference of East African police personnel tasked with taking forward the integration of these standards into their work.

- In Kenya, a Task Force was formed by the President and mandated to investigate police reform needs. They released an interim report and now a final report. The Police Reform Implementation Commission (PRIC) has been established to implement the recommendations. We have submitted critiques of bills, which have been well received by the Commission and they have indicated they are taking them into consideration.
- CHRI Africa attended a sub-regional conference on policing organised by APCOF in Dakar, Senegal from 22-24 November 2010.

ACCESS TO JUSTICE: PRISON REFORMS

Objectives of the Programme

To promote better responses from the criminal justice system to prisoner's legal rights and remedies and compliance with minimum standards of incarceration

Activities

- CHRI took up the case of a mentally ill patient Roy Verghese housed in Jaipur Central Prison for 18 years. In January 2011, Roy was released into the care and custody of his family, and has since been shifted to a mental health care facility near his family. CHRI drew the court's attention to the conditions of Baba Khan's imprisonment and mental health in addition to the procedural delay that had taken place for 7 years.
- CHRI had written in May 2010 drawing the court's attention to the inhuman conditions existing
 in Maharashtra's sub-jails. We based our letter on the report CHRI had prepared titled
 Maharashtra's Abandoned Prisons which was published in 2010. It played a significant role in
 informing the court about the degrading jail conditions, and prompted them to take steps to
 improve the situation. We are monitoring compliance with the Bombay High Court judgement
 that formulated a 6-month action plan to improve appalling conditions in sub-jails of
 Maharashtra.
- There was positive progress on the promotion of CHRI's Evaluation of the Period of Detention (EPoD) software or the addition of EPoD-like features into existing and new systems where it can be made. After discussions with the Department of Justice and the National Informatics Centre, it was agreed that NIC will incorporate EPoD-like features in their e-courts project in India.
- The IG-Correctional Services, West Bengal, issued directions for speedy implementation of newly amended sections in the Criminal Procedure Code (Cr.P.C) relating to mentally ill prisoners within a week of CHRI writing to him urging him to intervene as it could benefit several such prisoners unnecessarily detained in correctional homes across the state.
- CHRI initiated a collaborative project with the Legal Aid Society of the National University of Juridical Sciences' (NUJS), titled Shadhinota Towards Legal Empowerment. The project, currently operating in Presidency Correctional Home, one of the largest correctional facilities in the state, aims to build a bridge between the inmates in need of legal help and the legal aid lawyers from the Legal Aid Services who are mandated to render free legal aid. In addition to some releases on bail owing to our intervention, we are also pursuing underlying problems with the criminal justice system that came up from our interactions with the inmates, such as vacancy in courts, non-appearance of legal aid lawyers, allegations of demands for money by legal aid lawyers.
- CHRI has joined hands with International Bridges to Justice (India) Trust to organise training workshop for trial-court lawyers in Rajasthan

 CHRI Africa presented on "Ensuring compliance to international protocols on adherence to human rights in the treatment of detainees" at a conference for officials from various African countries on Correctional Services and Prisons Reforms held in Johannesburg from 25-28 October 2010.

ACCESS TO INFORMATION

Objectives of the Programme

To advocate for the institutionalisation of a regime of transparency at all levels of Government in Commonwealth countries – provide technical assistance, monitor implementation, create awareness and increase information available in the public domain - particularly in Africa, South Asia, India

Activities

India:

- CHRI strategically litigated before the Central Information Commission for compliance with section 4(1)(c) vis-à-vis the Delhi Police Amendment Bill and the *Public Interest Disclosure* and *Protection of Persons Making Disclosure Bill, 2010* (also known as the Whistleblower Bill). As a result, the Commission issued landmark decisions recommending the government of the National Capital Territory of Delhi and the Central Government for creating spaces for public consultation on draft Bills and draft Rules and Regulations before they are approved by the respective cabinets and introduced in the respective legislatures.
- CHRI was one of the civil society organizations to be invited by the Parliamentary Standing Committee on Personnel, Public Grievances, Law and Justice to make a deposition on the Whistleblower Bill on 14 February, 2011. CHRI made a presentation demonstrating the shortfalls in the Bill with respect to most of the international best practice standards as well as those recommended in the *Public Interest Disclosure and Protection of Informers Bill* prepared by the Law Commission of India in 2003.
- In January 2011, the coordinator's RTI paper and recommendations were included in the civil society draft report that provided inputs to the approach paper for the 12th Five Year Plan drafted by the Planning Commission of India.
- In March CHRI attended the 3rd 'National RTI Campaign' of The National Campaign for Peoples' Right to Information (*NCPRI*) in Shillong. CHRI's Access to Information Programme Coordinator was appointed Co-convenor of NCPRI at the meeting.
- Civil society efforts (in which CHRI played an active part) to resist proposed negative amendments to the RTI Act including a 250-word limit, one subject matter restriction and abatement of an appeal on the death of an applicant besides other changes have prevailed.
- CHRI had published and disseminated the first of the series of analysis of RTI Rules in the Judiciary – RTI Rules in the Supreme Court, the Delhi High Court and the subordinate Courts of Delhi.
- CHRI sends regular e-mail alerts to RTI e-discussion groups and list-serves on a wide range of RTI related issues. We have received several messages in appreciation of the contents of these email alerts. Some journalists have informed us that they used this database of email alerts as a resource for doing their articles on issues related to RTI, transparency and accountability. These email alerts are uploaded on our website for future reference.

South Asia:

CHRI organised its fourth 10-day South Asia learning programme from 7 to 17 November, 2010 with the support of FNF. The programme was attended by nine representatives of civil society

organisations from Bangladesh, Sri Lanka and Maldives. The purpose of the learning programme was to familiarise the participants with the right to information movement in India and educate them about the experience of implementing the RTI Act in India. Several of the participating members have become resource persons on RTI in their respective countries. There has been a growing demand from our partners in these countries to accommodate their representatives in the learning programme.

- Membership and postings to the South Asian Right To Information Advocates Network (SARTIAN) membership has increased significantly, and CHRI is looking at ways to institutionalise and strengthen the network.
- In Bangladesh, CHRI organised and resourced a two-day capacity building workshop on Bangladesh's Right to Information Act 2009 in September 2010 for representatives of civil society organizations and elected members of a few Union Parishads and Upa Zila Parishads in collaboration with Nagorik Uddyog, Bangladesh; attended a workshop by the Bangladesh Information Commission and Article XIX for designated officers in various ministries of the Government; invited to the inaugural program of a week long RTI campaign in Dhaka city; resourced a Manusher Jonno workshop for members of a group who are working with migrant workers at Daudkandi Union Parishad in Commila district; made a presentation on the opportunities and limitations of the use of ICT for RTI at a round table organised by the Affilitated Network for Social Accountability South Asia Region (ANSA-SAR), D.Net, World Bank Institute and Canadian International Development Agency (CIDA)
- CHRI collaborated with the Sharique project of InterCooperation based in Dhaka towards developing two training manuals on Right to Information, for Union Parishads and government line agencies, and for community members. The training modules were launched officially by the Chief Information Commissioner of Bangladesh at a national sharing event held in Dhaka in August 2010. CHRI collaborated with Nagorik Uddyog on publishing a RTI User Guide on Bangladesh's RTI Act 2009, and with Transparency International-Bangladesh on publishing the Bengali version of its publication, Implementing Access to Information.
- In March 2011, facilitated visit of Prof. Sadeka Halim, Information Commissioner of Bangladesh to her meeting with Mr. S.N. Mishra, Chief Information Commissioner, Central Information Commission, India
- In Sri Lanka, taking forward suggestions from our earlier consultation in 2009 to broaden the campaign for RTI legislation among the grassroots and not limit to a few Colombo based organisations, CHRI organised a two-day consultation on "Securing an Access to Information Legislation in Sri Lanka" on 22-23 November 2010 in collaboration with Sarvodaya, the largest grassroots NGO in the country, at their headquarters at Moratuwa. Findings from a CHRI-sponsored study of the disclosure provisions in local government laws were presented at this workshop to educate participants about RTI-based interventions they could undertake even in the absence of an over-arching RTI law, and participants showed a lot of enthusiasm about this.
- CHRI is collaborating with Transparency International-Sri Lanka to adapt and translate three
 chapters of CHRI's flagship publication Open Sesame: Looking for RTI in the Commonwealth
 into Sinhala and Tamil. The six booklets will be printed soon and launched at an event to be
 held in Colombo.
- In Maldives, CHRI resourced a sensitisation workshop organised by the Human Rights Commission of Maldives on RTI.

Africa:

Liberia passed its Right to Information Bill in August 2010 making it the first West African
country to have an information access law. This has led to strengthening of the demand for
information access legislation in Ghana and Nigeria. The Right to Information Coalition in
Ghana which was spearheaded by CHRI has been persistently urging the Government of
Ghana to act on the pending access to information legislation in the Parliament and has been

advocating for the adoption of the best practice standards in their legislation.

- CHRI Africa was chosen to be a member of the Steering Committee of Africa Freedom of Information Centre (AFIC)
- CHRI Africa is a member for the Governance Sector Working Group in Ghana and in a meeting held in the reporting period made a presentation on the status of the RTI Bill in Ghana.
- CHRI was invited to make a presentation on the situation regarding RTI and national security related information in India at a conference on National Security and Access to Information in October, 2010. This meeting was co-organised by OSJI and the Institute for Security Studies, South Africa and was attended by academics and representatives of CSOs and government security agencies.
- On request from a Rwandan Civil Society Platform, CHRI organised a six day study tour in April similar to our South Asia learning visit for three representatives from Rwanda, a part of the organisation's exchange visit in collaboration with the Norwegian People's Aid (NPA). The study tour is to learn about the Indian RTI campaign and implementation of the law.
