METHODOLOGY: Interactive sessions

UNIT 1

Aim: to develop a rapport between the participants and the facilitator

Methodology: interactive session

Seating: Informal - in a semi circle

Materials required: board and marker and CHRI Background Note.

Activity 1: Time: 30 minutes

- The facilitator will introduce her/himself and outline the objectives of the training programme.
- The facilitator will then ask the participants to introduce the person sitting to the right with the following information and share the information.
 - 1. Name?
 - 2. How long the person is working with the CSHRC?
 - 3. What was the nature of the last job the person was doing before joining the CSHRC?
 - 4. Does the person enjoy doing the work at the CSHRC?
 - 5. Is there anything that the person wants the participants to know about her/himself hobby, plans for the future?

Activity 2: Time: 40 minutes

Seating: Informal Group discussion time: 20 minutes Presentation by groups:15 minutes Facilitator: 5 minutes Subjects for group discussion:

1. What is the present situation of human rights in the country?

- 2. What is the present situation of human rights in Chhattisgarh?
 - Whether these problems are long standing/traditional or emerging problems?
 - What are the reasons contributing to the human rights problems?
 - Which are the groups that are the human rights violators list them.
 - Are they going scot-free because they belong to a powerful group/lobby?
 - Is there equality between men and women? If the answer is no, what is the reason for this situation?
 - How can human rights problems be tackled in Chhattisgarh?

Discussion: Time 45 minutes

- (A) As a human being what rights are required to live? Which are the rights which are most needed and which rights may be treated as second class rights?Distribute cards with different rights written on them and each participant explains the right with reference to the laws prevalent in the country.
- (B) Briefly discuss the background and the UDHR & covenants and why we should know about the international laws? How do we benefit. Relate this to the next session on fundamental rights. Time : 15 minutes

(C) Group Discussion: Time 20 minutes

Topic: Are women better off working at home than outside, as it is a man's world.
