CODE OF CONDUCT FOR MINISTERS (Both Union and State)

In addition to the observance of the provisions of the Constitution, the Representation of the People Act, 1951, and any other law for the time being in force, a person before taking office as a Minister, shall:

- a) disclose to the Prime Minister, or the Chief Minister, as the case may be details of the assets and liabilities, and of business interests, of himself and of members of his family. The details to be disclosed shall consist of particulars of all immovable property and the total approximate value of (i) shares and debentures, (ii) cash holdings and (iii) jewellery;
- sever all connections, short of divesting himself of the ownership, with the conduct and management of any business in which he was interested before his appointment as Minister; and
- c) with regard to a business concern which supplies goods or services to the Government concerned or to undertakings of that Government (excepting in the usual course of trade or business and at standard or market rates) or whose business primarily depends on licenses, permits, quotas, leases, etc., received or to be received from the Government concerned, divest himself of all his interests in the said business and also of the management thereof.

<u>Provided</u>, however, that he may transfer in the case of (b) his interest in the management, and in the case of (c) both ownership and management, to any adult member of his family or adult relative, other than his wife (or husband, as the case may be), who was prior to his appointment as Minister associated with the conduct or management or ownership of the said business. The question of divesting himself his interests would not arise in case of holding of share in public limited companies except where the Prime Minister, or the Chief Minister, as the case may be, considers that the nature or extent of his holding is such that it is likely to embarrass him in the discharge of his official duties.

After taking office, and so long as he remains in office, the Minister shall: -

- furnish annually by the 31st March to the Prime Minister, or the Chief Minister, as the case may be, a declaration regarding his assets and liabilities;
- (b) refrain from buying from or selling to, the Government any immovable property except where such property is compulsorily acquired by the Government in usual course;
- (c) refrain from starting, or joining, any business;

(d) ensure that the members of his family do not start, or participate in, business concerns, engaged in supplying goods or services to that Government (excepting in the usual course of trade or business and at standard or market rates) or dependent primarily on grant of licenses, permits, quotas, leases, etc., from that Government; and

- (e) report the matter to the Prime Minister, or the Chief Minister as the case may be, if any member of his family sets up, or joins in the conduct and management of, any other business.
- 3.1 No Minister should -
 - (a) personally, or through a member of his family, accept contribution for any purpose, whether political, charitable or otherwise. If any purse or cheque intended for a registered society, or a charitable body, or an institution recognised by a public authority, or a political party is presented to him, he should pass it on as soon as possible to the organisation for which it is intended; and
 - (b) associate himself with the raising of funds except for the benefit of (i) a registered society, or a charitable body, or an institution recognised by a public authority and (ii) a political party. He should, however, ensure that such contributions are sent to a specified officer bearer, etc. of the society or body or institution or party concerned and not to him. Nothing herein before shall prevent a Minister from being associated with the operation for disbursement of funds raised as above.

3.2 A Minister, including the Union Ministers, the Chief Ministers and other Ministers of State Governments/Union Territories, should not permit their spouse and dependents to accept employment under a Foreign Government, in India or abroad, or in a foreign organisation (including commercial concerns) without prior approval of the Prime Minister. Where the wife or a dependent of a Minister is already in such employment, the matter should be reported to the Prime Minister for decision whether the employment should or should not continue. As a general rule, there should be total prohibition on employment with a Foreign Mission.

4.1 A Minister should -

- a) not accept valuable gifts except from close relatives, and he or members of his family should not accept any gifts at all from any person with whom he may have official dealings; and
- b) not, either contract or permit a member of his family to contract debts of a nature likely to embarrass or influence him in the discharge of his official duties.

4.2 A Minister may receive gifts when he goes abroad or from foreign dignitaries in India. Such gifts fall into two categories. The first category will include gifts which are of symbolic nature, like a sword of honour, ceremonial robes etc. and which can be retained by the recipients. The second category of gifts would be those which are not of symbolic nature. If its value is less than Rs.5,000/- it can be retained by the Minister. If, however, there is any doubt about the estimated value of the gift, the matter should be referred to the Toshakhana for valuation. If the value of the gift, on assessment is found to be within the prescribed limit of Rs.5,000/- the gift will be returned to the Minister. If it exceeds Rs.5,000/- the recipient will have the option to purchase it from the Toshakhana

by paying the difference between the value as assessed by the Toshakhana and Rs.5,000/-. Only gifts of household goods which are retained by the Toshakhana, such as carpets, paintings, furniture etc. exceeding Rs.5,000/- in value, will be kept in Rashtrapati Bhavan, Prime Minister's House or Raj Bhavan as State property. (Note: The value of the gift refers to its approximate market value in the country of origin).

4.3 In case of grant of an award by any organisation to a Minister/a person holding the Minister's status/rank, the following procedure may be followed :-

- the credentials of the organisation giving award may be gone into;
- b) if the credentials of the body giving the awards are unimpeachable, the award as such may be accepted but the cash part should not be accepted;
- c) if the awards relate to the work done by the individual prior to his holding the office of Minister, such awards may be accepted but in all such cases specific approval of the Prime Minister or the Chief Minister as the case may be, should be obtained. The Chief Minister and other Ministers shall have to take permission of the Prime Minister and the Union Home Minister; and
- d) those instances, where a Minister is to receive any award by any organisation which has connections with any Foreign Agencies/Organisations, such a Minister/ a person holding the Minister's status/rank, will have to seek prior approval of the Prime Minister of India.

4.4 A Minister should follow the instructions given from time to time by the Prime Minister in matters relating to attending functions arranged by foreign missions in India or abroad, and also for accepting the membership of any foreign trust, institution or organisation other than U.N. Organisations of which India is a Member.

- A Minister should -
 - a) while on official tour, as far as practicable stay in accommodation belonging to himself or maintained by Government, Government undertakings, public bodies or institutions (such as circuit houses, dak bungalows etc.) or in recognised hotels; and
 - b) avoid attending, as far as possible, ostentatious or lavish parties given in his honour.

6. The authority for ensuring the observance of the Code of Conduct will be the Prime Minister in the case of Union Ministers, the Prime Minister and the Union Home Minister in the case of Chief Ministers, and the Chief Minister concerned in the case of State Ministers except where it is otherwise specified. The said authority would follow such procedure as it might deem fit, according to the facts and circumstances of each case, for dealing with or determining any alleged or suspected breach of this Code.

Explanation: In this code, a Minister's family shall include his wife (or husband, as the case may be) not legally separated from him (or her), minor children, and any other persons related by blood or marriage to, and wholly dependent on the Minister.

Copy of CONFIDENTIAL letter No. CDP-2068-DI dated the 24th May, 1968 from the Deputy Secretary to the Govt. of Maharashtra, General Administration Department, addressed to the Secretary to the Govt. of India, Ministry of Home Affairs, New Delhi.

Subject :- Code of Conduct for Ministers.

I am directed to refer to the Code of Conduct for Ministers prescribed by the Government of India and to state that this Government has also adopted a Code on the same lines for the Ministers and Deputy Ministers in this State. Rule 3(a) of the Code adopted by this Government which corresponds to Rule 3(a) of the Code of the Government of India provides that, 'No Minister/Deputy Minister should personally or through a member of his family, accept contribution for any purpose, whether political, charitable or otherwise; if any purse or cheque intended for a registered society, or a charitable body or an institution recognised by the public authority, or a political party is presented to him he should pass it on as soon as possible to the organisation for which it is intended. Strictly according to its working the rule seems to contemplate that a Minister or Deputy Minister can accept a purse or cheque only if it is intended for a specific organisation which already exists and that he cannot accept it otherwise though it is intended for a charitable or political purpose. The rule would also mean that unless the donors ear-mark the purse or cheque for a particular organisation, the Minister/Deputy Minister cannot accept it though donors may intend that he should pass it on to any charitable or political organisation which he himself may select.

2. There may be occasions when a Fund may have to be started for a charitable purpose e.g., where a collection is made for urgent flood relief or for helping people in a natural calamity, but the Fund/Trust is yet to be constituted. It appears from the wording of the Rule 3(a) of the Code referred to above that in such a case the Minister/Deputy Minister would be precluded from accepting a purse or a cheque intended for such a Fund/Trust. This is bound to cause considerable embarrassment to the Minister/Deputy Minister if despite the fact that the purse or cheque is intended for a genuine charitable purpose he cannot accept it. It may also cause him embarrassment if he is required to refuse a purse or cheque offered by donors who decide to leave it to him to select the organisation to which it should be passed on.

3. I am to enquire whether the Government of India have taken into account a contingency of the type mentioned above and if so, whether it is intended that a Minister should not accept any purse or cheque in such cases whatever may be the circumstances. It appears that so long as a Minister/Deputy Minister does not retain a purse or cheque presented to him for a charitable or political purpose himself but passes it on to an appropriate institution or political party for a purpose for which it is intended there should no objection to his accepting such a purse or cheque.

4. I am to request that the Government of India may kindly be moved to advise the State Government as to what is intended to be done in cases of the type mentioned above.

Subject:- Code of Conduct for Ministers.

I am directed to refer to your letter No. CDR-2068-D-I, dated the 24th May, 1968, on the above subject and to say that under the provisions of the Code of Conduct for Ministers, the circumstances under which a Minister can accept purses and cheques are rather limited. The purse or cheque is to be for a registered society, or a charitable body or an institution, recognised by a public authority or a political party. It has to be for a specific purpose and for a specific body and if there is any vagueness about it, such a purse or cheque is not to be accepted. Where a fund has not been constituted or where the donor desires that the Minister should pass on the purse or cheque to any charitable or political organisation which he himself may select, the intention of the Code is that in such circumstances, the donation should not be accepted by the Minister. This is not likely to cause any embarrassment as the Minister can always explain the circumstances under which he cannot accept the same, citing the Code. If anything at all, the public will appreciate such a gesture on the part of the Minister and the refusal, in the circumstances, would enhance the prestige of the Minister rather than embarrass him.

Subject:- Code of Conduct for Ministers.

I am directed to say that doubts have been raised whether the clarification contained in this Ministry's letter of even number dated the 13th August, 1968 would also be applicable to regularly constituted Funds such as the National Defence Fund or the Prime Minister's National Relief Fund. The matter has been gone into carefully. Rule 3 of the Code of Conduct for Ministers merely emphasises that the society or a charitable body or institution on whose behalf a purse or cheque is received should be a registered body or recognised by a public authority or a political party. Regularly constituted Funds like the National Defence Fund and the Prime Minister's National Relief Fund would naturally fall within this category. The existing practice also supports this view, since there have been occasions when moneys were received by Central/State Ministers for being credited to the National Defence Fund or the Prime Minister's National Relief Fund. By necessary implication similar Funds set up at the State level would also fall in the same category. In the case where Ministers receive purses/cheques for being credited to the National Defence Fund, the Prime Minister's National Relief Fund or other funds of the same nature, there can be no objection to Ministers accepting them, but the amounts received by them may please be passed on to the Fund concerned at the earliest possible date.

 In this connection attention is also invited to the State Government's letter No.CDR-2068-D-I, dated the 24th May, 1968.

You would recollect that in 1964, we adopted a Code of Conduct for Ministers of the Central Government, and also asked State Governments to adopt it in respect of the Ministers of the State Governments.

While the Code provides guidance on several aspects, it does not include any guidelines concerning employment of sons and daughters or dependents of Ministers under foreign governments in embassies in India or abroad, or under other foreign organisation (including commercial concerns). It has been felt that there is need for adopting some conventions in this regard. Recently, a question was also asked in the Parliament regarding such employment.

Following careful consideration of the problem, the Prime Minister has come to the conclusion that wives and dependants of Ministers should not accept employment under a foreign government in India or abroad, or in a foreign organisation (including commercial concerns) without her prior approval. Where the wife of a dependent of a Minister is already in such employment, the matter should be reported to the Prime Minister for decision whether the employment should or should not continue. The Prime Minister has further agreed that, as a matter of policy, in deciding these cases, the need to avoid risk of leakage of confidential information and the desirability of the holder of a public office not taking an obligation which may be embarrassing, will have to be kept in view. As a general rule, there should be total prohibition on employment with a foreign mission. In other cases, the nature of employment the qualifications of the candidate, the emoluments offered etc. will have to be considered.

I am addressing the Chief Ministers of the State also be consider adopting a similar policy in respect of Ministers in the State Governments.

In his letter No. 73/215/CF-69 dated the 10th June, 1969, Home Minister had advised you of the conventions which it had been decided to follow in the matter of employment of sons and daughters or dependents of Ministers, under foreign governments, in embassies in India or abroad, or under other foreign organisations (including commercial concerns). A question has since been raised as to what the definition of the term "dependents" is. This has since been considered in consultation with the Ministry of Home Affairs, and it has been agreed that the term "dependents" may be taken "to include any person related, whether by blood or marriage to the Minister and wholly dependent on him".

2. I am to request that the information already supplied with reference to my letter No. 75/215/CF-69 dated the 26th March, 1969, may kindly be revised in the light of the above clarification and changes, if any intimated for the information of the Prime Minister

Subject: Disposal of gifts received from foreign dignitaries by Ministers and Deputy Ministers.

The Code of Conduct for Ministers contain a general provision to the effect that a Minister should not accept valuable gifts except from close relatives and that he or members of his family should not accept any gifts from any person with whom he may have official dealings. It has not, however, been specified what constitute a valuable gift and how the gifts should be disposed of.

Ministers may receive gifts when they go abroad or from foreign dignitaries in India. Such gifts fall into two categories. The first category will include gifts which are of symbolic nature, like a sword of honour, ceremonial robes etc., and which can be retained by the recipients. The second category of gifts would be those which are not of symbolic nature. When a Minister receives a gift of this nature, he may bring it to the notice of the Prime Minister indicating the estimated value of the gift. If its value is less than Rs. 3000/-, it can be retained by the Minister. If, however, there is any doubt about the estimated value of the gift, the matter can be referred to the Toshakhana for valuation. If the value of the gift, on assessment is found to be within the prescribed limit of Rs. 3000/- the gift will be returned to the Minister. If it exceeds Rs. 3000/-, the recipient will have the option to purchase it from the Toshakhana by paying the difference between the value as assessed by the Toshakhana and Rs. 3000/-. Gifts of household goods, such as carpets, paintings, furniture etc. exceeding Rs. 3000/-, in value will be kept in the Rashtrapati Bhavan, Home Minister's house or Raj Bhavans State property.

Association of the Ministers of the Union Government with the editorial boards of newspapers and periodicals.

A question has been raised whether the Ministers of the Union Government can lend their names to the editorial boards of the newspapers and periodicals. The Code of Conduct for Ministers does not specifically cover, cases of this kind, as it mainly refer to ownership, conduct, and management of business, etc. However, in June 1950 and 1951 general instructions has been issued to the effect that a Minister should cease to hold office in other organisations e.g., Directorship, honorary or remunerative, or active membership in private companies or public corporations, trade unions, local semi-Government institutions, and so on. Two exceptions are made to this. It was held that there was no objection to a Minister holding ex-officio membership of bodies in the Senate/Syndicate/Court of University, etc. The other exception was that they could continue to function as honorary office bearers of philanthropic organisations. These instructions were clarified from time to time on inquiries made by State Governments. In 1953, the State Governments were informed that the association of a Minister with a newspaper in any capacity was not covered by these two exceptions and that on appointment to the office of Minister he should dissociate himself in every way from the newspapers. The Ministers are, therefore, not expected to be on the editorial boards of the newspapers or periodicals. This does not, however, preclude a Minister from contributing to newspapers and periodical articles explaining the policies of the Government or articles of literary, artistic or scientific character.

The declaration would contain details for the previous financial year.

In accordance with the Code of Conduct for Ministers, the Members of the Union Council of Ministers are required to disclose to the Prime Minister, the details of the assets and liabilities and of business interests, of himself/herself and of members of his/her family. In partial modification of the existing provisions of the Code in this regard, it has been decided, with the approval of the Prime Minister, to extend the time limit for furnishing the annual declaration of assets and liabilities specified in paragraph 2 of the Code, up to 31st August instead of 30th June of every year. The declaration would contain details for the previous financial year.

Further, in terms of the provisions of paragraph 1 of the Code, a person 2. before taking oath as a Minister, is required to disclose his assets and liabilities. Prime Minister has also approved that this provision be modified to the extent that the details of assets and liabilities will now be required to be furnished by a Minister immediately after entering office, and in any case within a period of two months from the date of assumption of office. Such a statement of assets and liabilities could be in respect of the financial year for which the Income tax return has already been filed by the Minister.
