#### REPLY AFFIDAVIT ON BEHALF OF THE STATE OF JHARKHAND

I, Tushar Ranjan Gupta, son of Late S.N. Sahu resident of Jharkhand,
Ranchi P.O.- Doranda, P.s.- Doranda, District- Ranchi and presently at
Ranchi do hereby solemnly affirm and state as under:-

- 1. That I am presently posted as Assistant Inspector General of Prisons,

  Jharkhand and have been duly authorized by the competent
  authority to affirm the instant affidavit on behalf of the State of

  Jharkhand. That, in my official capacity I am well acquainted with the
  facts and circumstances of the case and thereof, competent to affirm
  the instant affidavit.
- 2. That, while every effort has been made to answer all the issues raised in the above captioned Writ Petition, the facts which have not been specifically denied may not be deemed to be admitted.

However, the deponent craves liberty of this Hon'ble Court to file a detailed reply at a later stage, if so directed or required.

- That, the instant affidavit is being filed in terms of the order dated 3. 01.06.2021 passed by this Hon'ble Court in the above captioned matter. vide the aforesaid order dated 01.06.2021 this Hon'ble Court was pleased to direct the Chief Secretaries/ Administrators, Home Secretaries, Directors General of all the prisons and the Department of Social Welfare of all the States and Union Territories, to show cause why directions should not be issued for dealing with the present health crisis arising out of Corona Virus (COVID-19) in the country, and further to suggest immediate measures to be adopted for the medical assistance to the prisoners in the jails and the juveniles lodged in the Remand Homes and for protection their health and welfare.
- 4. That in the light of direction of Hon'ble Supreme Court of India in Suo Moto Writ Petition (C) No. 01/2020 in Re: Contagion of Covid-19 Virus in Prison vide Order dated 23.03.2020 total no. of prisoners released (interim/ regular bail etc.) since dated 23.03.2020 to

16.05.2021 is 29,478 out of which 105 prisoners are returned, and total number of convict prisoners released on parole is 146.

5. That in the light of direction of Hon'ble Supreme Court of India in Suo Moto Writ Petition (C) No. 01/2020 in Re: Contagion of Covid-19

Virus in Prison vide Order dated 07.05.2021 & High Powered

Committee meeting held on 17.05.2021, it is submitted that from

17.05.2021 to 15.06.2021 total number of prisoners released on bail is 961 & interim bail is 207 and the total number of prisoners released on Parole is 121 from the Jails of Jharkhand State.

6. That in the light of Hon'ble Court's order it is submitted that the total number of prisoners' death due to Covid-19 pandemic is 02 in the prisons of Jharkhand State.

List of deaths prisoners due to Covid-19 pandemic in the prisons annexed as Annexure- 'C'

7. That it is submitted that the last meeting of the Jharkhand State sentence review board was held on 17/20.07.2020 and 4.12.2020/25.02.2021 and 79 + 26 = 105 life convicted prisoners were released. It is also submitted that the date of next meeting of the Jharkhand State sentence review board is in process for the purpose of premature release of Life Convicted prisoners of Jharkhand State.

List of 105 released convict prisoners annexed as Annexure-'D'.

8. That, the total capacity of Jharkhand Prisons is 17,096 out of which 22,357 prisoners are lodged at present in various prisons, so the percentage of occupancy of Jharkhand prisons at present is 130.77%.

343 prisoners have been transferred from more overcrowded prisons to other prisons. •

- 9. That, even otherwise, if this Hon'ble Court is pleased to pass any direction in this regard, the respondent State of Jharkhand being duty bound and having highest regard to the majesty of this Hon'ble Court shall comply with in its letter and spirit.


