- I, Sunil Ramanand, Age: 53 Years, Additional Director General of Police and Inspector General of Prison and Correctional Services, State of Maharashtra, having my office at Pune-1, do hereby state on solemn affirmation as under:
- 1. I have gone through a copy of the order dated 1.06.2021, passed by this Hon'ble Court in Suo Motu Writ Petition (Civil) No. 1 of 2020. I am filing this Affidavit in my official capacity and as per records available in my office and in compliance of the order dated 1.06.2021, passed by this Hon'ble Court in Suo Motu Writ Petition (Civil) No. 1 of 2020.
- 2. The order dated 1.06.2021, passed by this Hon'ble Court in Suo Motu Writ Petition (Civil) No. 1 of 2020 inter alia directs the States/Union Territories have to file an Affidavit furnishing information about:
  - (a) the number of prisoners released pursuant to the order dated 07.05.2021;
  - (b) information relating to the number of deaths in prisons due to COVID 19.

3. With regard to the number of prisoners released pursuant to the order dated 07.05.2021, I say that as of date 06/06/2021 a total of 12,081 prisoners have been released to prevent contagion spread of COVID-19 Virus in Prisons in the State. Charts showing (i) the total number of 12,081 prisoners released, including 2792 prisoners released on emergency parole and 9289 prisoners released on bail are hereto annexed and marked Annexure 'R-1' (Page 1).

4. With regard to the information relating to the number of deaths in prisons due to COVID 19, I say that a total of 13 prisoners have died in prisons due to COVID 19, and a total of 9 jail staff has died due to COVID 19. A Chart showing the total number of deaths in prisons due to COVID 19 is hereto annexed and marked Annexure 'R-2' (Pages 1 to 2).

5. I say that the State has complied and/or is taking steps to comply with the directions and/or orders that have been passed and/or may be passed by this Hon'ble Court in Suo Motu Writ Petition (Civil) No. 1 of 2020, in letter and spirit.

6. Hence the Affidavit.
