MOST RESPECTFULLY SHEWETH:

I, Siladitya Chakraborty, aged about 43 years, working as Senior Law Officer & ex officio Assistant Secretary(Law) under the Department Of Correctional Administration, Govt. of West Bengal having office at 63, Netaji Subhas Road, Kolkata-700001 do hereby solemnly swear, affirm and state as hereunder:

1. That I am authorized to file the instant affidavit on behalf of the State Respondent in the captioned matter. I have read and understood the contents of the instant affidavit along with the

accompanying documents, which is based on my personal knowledge as derived from the official records, maintained by the State of West Bengal. The legal submissions advanced in the present affidavit are based on legal advice furnished to me, which are believed to be true and correct.

2. That this present affidavit is filed in pursuance of the order dated 01.06.2021 wherein this Hon'ble Court was pleased to direct the States & UTs to:

"...file an affidavit within a period of four weeks furnishing information about the number of prisoners released pursuant to the order dated 07.05.2021. The State Governments/Union Territories shall also provide information relating to the number of deaths in prisons due to Covid-19."

- In view of the afore-said order, it is most respectfully stated that (as on 04.06.2021):
 - a. 2708 convict prisoners were issued parole orders for three months pursuant to this Hon'ble Court's order dated
 07.05.2021;(These convicts were released on parole in 2020, as well)
 b. 3 prisoners died of COVID-19 in 2020; and

c. 4 prisoners died of COVID-19 in 2021.

A true copy of the letter no. 452/ADG-IG/21 dated 04.06.2021 from the Correctional Services, West Bengal dated 04.06.2021 specifying the number of prisoners released in pursuance of this Hon'ble Court's order dated 07.05.2021 is annexed and marked as ANNEXURE A (Page No. 9).

A true copy of the information in relation to the 7 deaths in prison due to COVID-19 from 03.08.2020 to 04.06.2021 is annexed, and marked as ANNEXURE B (Page No. 10 to 11).

4. It may be noted that the High Powered Committee initially recommended the parole of 2770 convicts, out of which only 2708 convicts were released on parole; the remaining 62 convicts were excluded due to reasonable apprehensions as enclosed herewith.

A true copy of the report containing the rationale behind excluding 62 prisoners from parole is annexed and marked as ANNEXURE C (Page No.12 to 14).

5. Furthermore, it is most respectfully submitted that medical care is being provided to all prisoners in Correctional Homes within the available facilities in Correctional Homes and outside Government

Health Institutions as per necessity.

- 6. It may also be imperative to state that the Correctional Homes in West Bengal are:
 - a. Ensuring proper screening (temperature/ symptom/background) of every incoming prisoners;
 - b. Isolating newly admitted prisoners and monitoring over their health;
 - c. Ensuring RAT / RT -PCR tests of newly admitted prisoners and suspected staffs reporting for duty.
 - d. Training medical sub-ordinates like pharmacists for holding RAT / RT-PCR tests of prisoners in co-ordination with the State Health Department. Test kits are being provided by local Health authorities. (7727 prisoners and 316 employees have been tested RAT / RT-PCR under this drive in 2021)
 - e. Implementing the vaccination drive, which has been undertaken in Correctional Homes with the help of Health & Family Welfare Department (2995 employees have been vaccinated out of 3489, whereas, 15637 prisoners have been vaccinated so far (prison population 24838);
 - f. Ensuring regular sanitization / disinfection of Correctional
 Home premises.
 - g. Emphasizing personal sanitation and hygiene of prisoners and staff.

- 7. Additionally, it is most respectfully submitted that the Jail Superintendents have been instructed to identify all elderly persons lodged in Correctional Homes and to ensure locally their periodical review of general, physical and mental health conditions. The Correctional Home authorities are taking up with the issues with local District / Sub-Divisional Health authorities wherever such facilities are not available in Correctional Homes.
- 8. In view of the aforesaid, it is most respectfully submitted that the State of West Bengal is committed towards the de-congestion process of Correctional Homes as per this Hon'ble Court's directions.
- However the Respondent herein reserves the right to adduce further necessary documents or submissions through additional affidavits as and when required, or directed by this Hon'ble Court.



With reference to above the undersigned is to furnish the requisite information as follows:

- Number of Prisoners released pursuant to the previous order dated 07.05.2021 in the captioned item.
 - Reply. High Powered Committee recommended for parole in r/o 2770 convicts.
 - Parole Orders for three months have been issued in favour of 2708 convicts.
 - Parole could not be granted to 62 convicts due to several administrative reasons.
 - No UTPs could be recommended by High Powered Committee for bail since the UTPs who were granted interim bail last year are not detained in Correctional Home at present.
 - A fresh list of 652 UTPs has been placed before High Powered Committee for further consideration.
- 2. Number of deaths in prisons due to COVID-19.

Reply. Three (3) prisoners died of COVID-19 in 2020. Four (4) prisoners died of COVID-19 in 2021.

This is for information. Further development will be intimated in due course.
