

6.1) On 21/12/2017 this Appellants despatched by Speed Post a request for information to the PIO mentioned along with the prescribed application fee, stating as follows (**Annexe 1**):

We, the residents of Jammu and Kashmir, would like to obtain, under the J&K RTI Act, the following information pertaining to the implementation of the Jammu and Kashmir Public Safety Act, 1978 (the said Act) from your public authority:

- 1) A clear photocopy of the official notification constituting the Advisory Board under Section 14(1) of the said Act;
- 2) A clear photocopy of the official notification of appointment of the current Chairman and two other current Members of the said Advisory Board under Section 14(3) of the said Act, along with their names and contact details:
- 3) The complete postal address, telephone number, fax number and email address of the said Advisory Board; and
- 4) A clear photocopy of any document containing details of the salary and the compensation package offered to the Chairman and the other two Members of the said Advisory Board;
- 5) The names, designations, grades and salary scales of all officers and employees currently servicing the said Advisory Board; and
- 6) A clear photocopy of all study reports commissioned till date, by the Government to assess the manner of implementation of the said Act.
- **6.2)**This Appellants are aggrieved by the non response of the said PIO against the instant RTI application for reasons explained below.

7) Prayers or relief sought

This Appellant prays that this First Appellate Authority be pleased to:

- 1) admit this appeal and inquire into the matters raised herein;
- order the disclosure of all the information sought in the said RTI application, free of charge in accordance with Section 7(6) of the J&K RTI Act; and
- 3) make a reference against the PIO specified above to the J&K State Information Commission for imposition of penalty vide Section 16(3) read with Section 17(1) of the J&K RTI Act.

8) Grounds for the prayer or relief

- **8.1)** According to Section 16(1) of the J&K RTI Act, any person who is aggrieved by a decision of the PIO may prefer a first appeal to an officer, senior in rank to him, within 30 days of receiving the decision. This first appeal is being submitted on the 30th day of the expiry of the PIO's non disclosure of the information which is well within the statutory deadline stipulated in Section 16(1) of the J&K RTI Act. This Appellant is aggrieved with the non response of the PIO for reasons explained below:
- **8.1.1**) Further, Section 5(3) of J&K RTI Act places a duty on every PIO to render reasonable assistance to persons seeking information. Instead of providing reasonable assistance to this Appellant, the PIO has not disclosed the information and has not responded to the application. Hence the submission of this first appeal to this Hon'ble First Appellate Authority.
- **8.1.2)**Further, Section 7(6) of the J&K RTI Act entitles an RTI applicant to receive all information free of charge if the same is not provided within the timeline of 30 days stipulated in Section 7(1) of the J&K RTI Act. More than 30 days have gone by since the submission of the instant RTI application to this Public Authority. This Appellant seeks to invoke his right recognised under Section 7(6) of the Act and demands access to all information requested, free of charge. *Hence the submission of this first appeal to this Hon'ble First Appellate Authority.*
- **8.1.3**) Further, according to Section 16(3) of the J&K RTI Act, at the time of deciding an appeal if the first appellate authority forms an opinion that the PIO whose order is challenged under the terms of Section 16(1) of the J&K RTI Act, has obstructed in any manner the furnishing of information under the Act, he shall make a reference to that effect to the State Information Commission. This Appellant has explained above how the non responsible behaviour of the PIO are aimed at causing obstruction to access to information under the Act. This Appellant believes that this is a fit case for reference to the J&K State Information Commission for initiating appropriate action for imposition of penalty under Section 17(1) of the J&K RTI Act. Hence the submission of this first appeal to this Hon'ble First Appellate Authority.
- 9) I hereby verify that the aforementioned facts are true to the best of my knowledge. I also declare that I have authenticated the Annexes to this appeal.
