Whereas, an appeal dated 30.08.2017 of Adeela Shah and Naveed Bukhtiyar R/o Shah e Jeelan Colony, House No-1, Budshah Nagar, Natipora, Srinagar, was received in the office of undersigned on 08.09.2017( Afternoon); and

- 2. Whereas, the contents of the appeal indicated that the appellants are aggrieved of the alleged non response of the PIO, Home Department against the RTI application and filed First appeal in terms of Section 16(1) of the RTI Act, 2009 before the First Appellate Authority, praying, inter-alia, for the following reliefs:-
  - 1) Admit this appeal and inquire into the matter raised herein.

This Appellant would like to point out that the IPO was not drawn in favour of the Accounts Officer of this Public Authority due to oversight. Instead of providing reasonable assistance to this Appellant, the PIO mentioned at para #3 above has proceeded to reject the instant RTI application in a cavaller manner without paying any heed to his assigned duty under Section 5(3) of the J&K RTI Act. This Appellant is aggrieved by the unhelpful attitude of the said PIO. Hence the submission of this first appeal to this Hon'ble First Appellate Authority.
- 10.1.3) According to section 7(1) " Subject to the proviso to sub Section (2) of section 5 or the proviso to sub-section (3) of section 6, the Public Information Officer on receipt of a request under section 6 shall, as expeditiously as possible, and in any case within thirty days of the receipt of the request, either provide the information (1) on payment of such fee as may be prescribed (2) or reject the request for any of the reason specified in sections 8 and 9." This section clearly mentions that application should be disposed of as expeditiously as possible and response of PIO shows that it would have taken him only 15 minute to write a reply then for what reason he has taken so much time to respond the appellants, Further Section 8 and 9 of 3&K RTI Act mentions the grounds on which information can not provided, but

not mention the ground on which PIO has rejected this application. It indicates that have replied appellants as early as possible without wasting their precious time.

- 10.2) Further, Section 7(6) of the J&K RTI Act entitles an RTI applicant to receive all information free of charge if the same is not provided within the timeline of 30 days stipulated in Section 7(1) of the J&K RTI Act. More than 30 days have gone by since the submission of the instant RTI application to this Public Authority. This Appellant seeks to invoke his right recognised under Section 7(6) of the Act and demands access to all information requested, free of charge. Hence the submission of this first appeal to this Hon'ble First Appellate Authority.
- 10.3) According to section 17(1) "Where the State Information Commission at the time of deciding( any complaint, appeal or reference is of the opinion that the Public Information Officer has, without any reasonable cause refused to receive an application for information or has not furnished information within the time specified under sub-section (I) of section 7 or malafidely denied the request for information or knowingly given incorrect, incomplete or misleading information or destroyed information which was the subject of the request or obstructed in any manner in furnishing the information, it shall impose a penalty of two obstructed in any manner in furnishing the information, it shall impose a penalty of two
