Under the Right to Infromation Act 2005 I had requested for a copy of the list of topics on the agenda of all meetings of the Union Cabinet held between 1st August 2009 and 3rd September 2009. Readers will note that item no.7 on the agenda for 27.08.2009 has been "severed in terms of section 10(1) of the RTI Act, 2005". Section 10 (1) of the RTI Act is about severability.

" **10**. (1) Where a request for access to information is rejected on the ground that it is in relation to information which is exempt from disclosure, then, notwithstanding anything contained in this Act, access may be provided to that part of the record which does not contain any information which is exempt from disclosure under this Act and which can reasonably be severed from any part that contains exempt information."

Severing information amounts to rejection of a portion of the information requested. This can be done only by invoking the relevant ground/s under section 8(1). However the PIO has not offered any explanation about why this information is being severed. Therefore we will file an appeal under section 19 (1) of the RTI Act with the Cabinet Secretariat.
